(+)- δ^9 -THC is a different compound from the main (-)- δ^9 -THC cannabinoid and, therefore, these two compounds may have different efficacies. Using the most advanced instruments and techniques available, the separation of (+)- δ^9 -THC and δ^9 -THC is problematic for the scientific community as a whole. 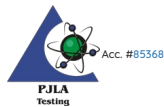
